## FIRST AMENDMENT OF THE DEDICATION, PROTECTIVE RESTRICTIONS, COVENANTS, LIMITATIONS, EASEMENTS AND APPROVALS APPENDED TO THE PLAT OF THE RETREAT AT HAWTHORNE PARK ESTATES, A SUBDIVISION IN PERRY TOWNSHIP, ALLEN COUNTY, INDIANA

WHEREAS, North Eastern Development Corp., an Indiana corporation ("Declarant"), executed and recorded the Dedication, Protective Restrictions, Covenants, Limitations, Easements and Approvals Appended to the Plat of The Retreat at Hawthorne Park Estates at Document No. 2020039476 in the Office of the Recorder of Allen County, Indiana (the "Declaration"); and

WHEREAS, pursuant to Section 7.26.2 of the Declaration, the Declarant currently has the right to amend the Declaration; and

WHEREAS, capitalized terms as used herein shall have the same meaning ascribed to them or defined in the Declaration unless otherwise specifically defined herein.

NOW, THEREFORE, the Declarant hereby amends the Declaration as follows:

1. <u>AMEND SECTION 7.1</u>. Section 7.1 is hereby amended to delete the following sentence:

"No building shall be erected, altered, placed, or permitted to remain on any Lot other than one single-family residence not to exceed two and one-half stories in height."

The deleted sentence is hereby replaced with the following sentence:

"No building shall be erected, altered, placed, or permitted to remain on any Lot other than one single-family residence not to exceed two and one-half stories in height, (i) except that the pre-existing structure located on Lot 1, erected prior to the execution and recording of this Declaration shall be permitted to remain and (ii) except all Lots shall be allowed to have an outbuilding which shall not exceed thirteen hundred (1300) square feet in surface area and two stories in height and must be approved by the Architectural Committee."

2. <u>MISCELLANEOUS</u>. Except as modified herein, the Declaration shall remain in full force and effect.
