**FIRST AMENDMENT OF DEDICATION, PROTECTIVE RESTRICTIONS,  
COVENANTS, LIMITATIONS, EASEMENTS AND APPROVALS APPENDED  
TO THE PLAT OF EDENBRIDGE, SECTION I,  
IN PERRY TOWNSHIP, ALLEN COUNTY, INDIANA**

**WHEREAS**, North Eastern Development Corp (“Declarant”), formerly known as NWM Corp., Inc., an Indiana corporation, executed and placed of record that certain Dedication, Protective Restrictions, Covenants, Limitations, Easements and Approvals appended to the Plat Edenbridge, Section I, in Perry Township, Allen County, Indiana recorded August 2, 2017, at Document Number 2017041205 in the Office of the Recorder of Allen County, Indiana, (collectively the “Declaration”); and

**WHEREAS**, pursuant to Article 7.27.2 of the Declaration, the Declarant currently has the right to amend the Declaration; and

**WHEREAS**, capitalized terms used herein shall have the same meaning ascribed to them in the Declaration.

**NOW, THEREFORE**, the Declarant hereby amends the Declaration as follows:


1. The definition of the word “Association” in Article 1.2 of the Declaration is deleted and in its place and in full substitution thereof, the word “Association” in the Declaration is now defined as and shall now refer to and mean the Fox Hollow Homeowners Association Inc.
2. The definition of the word “Subdivision” in Article 1.17 of the Declaration is deleted and in its place and in full substitution thereof, the word “Subdivision” in the Declaration shall now refer to and mean Edenbridge, Section I and all existing and future sections of Fox Hollow
3. Except as expressly modified or amended by this First Amendment, all other terms and provisions of the Declaration remain unchanged and shall remain in full force and effect.


