AMENDMENTS TO CODE OF BY-LAWS OF FOXCHASE CONDOMINIUMS HORIZONTAL PROPERTY REGIME

Section 3.01 is hereby amended to read as follows:

Section 3.01. The affairs of the Association shall be governed and managed by the Board of Directors (herein collectively called the "Board" or "Directors", and individually called "Director"). The Board of Directors shall be composed of FIVE (5) persons. No person shall be eligible to serve as a Director unless he is an Owner or Declarant or is an attorney, agent or employee of Declarent.

Section 5.06 is hereby amended to read as follows:

Every Owner shall promptly perform all maintenance and repair within his own Home, which, if neglected, would affect the value of the Property. Maintenance and repairs for which the Owner is responsible to make at his expense include, but are not necessarily limited to, water, gas, plumbing and electric lines which service the Owner's Home only and are located within exterior walls of the Home, including any lines in the area from below the floor to above the roof if they are within an extension of the exterior walls of the Home; appliances to include garbage disposals, diswashers, stoves, ranges and refrigerators, telephones, air conditioning and heating equipment, doors, screens, windows, to include exterior and interior of all glass and screen surfaces, lamps, interior and exterior grouting and/or caulking, and all other Accessories appurtenant to the Home. Also included with the Owner's obligation is the obligation to pay for or to reimburse the Association for all maintenance and replacement of roofs, skylights, chimneys, and gutters, but the risk of loss from insurable casualty as to roofs, skylights, chimneys, and gutters shall remain with the Association.

AMENDMENTS TO DECLARATION OF FOXCHASE CONDOMINIUMS

The first paragraph of Section 15 shall be amended to read as follows:

Replacements. Each Owner shall, at his expense, be responsible for the maintenance, repairs, decoration and replacement within his own Home together with the obligation to pay for or reimburse the Association for repair and replacement of roofs, skylights, chimneys and gutters, except as may otherwise be provided in the By-Laws, but the risk of loss from insurable casualty as to the roofs, skylights, chimneys and gutters shall remain with the Association. Each Owner shall repair any defect occurring in his Home which, if not repaired, might adversely affect any Condominium Unit, Common Area, or Limited Area. Maintenance, repairs, replacements and upkeep of the Common Areas and Limited Areas shall be furnished by the Association, and shall be chargeable by the Association to all Homes or fewer than all Homes as the Declaration, the By-Laws and rules and Regulations of the Condominium Project shall provide.
