

## **Indiana Board of Health Regulations & Hawthorne Park Pool Rules**

### **WARNING – NO LIFEGUARD ON DUTY! NO ONE SHOULD SWIM ALONE.**

1. Take a warm soapy shower before entering the pools.
2. Spitting, spouting of water, blowing the nose and other similar behavior in the swimming pools is prohibited.
3. No running, boisterous or rough play will be permitted in the pools, on the deck, or in the pool house.
4. Persons with infectious diseases or open sores are prohibited from using the pools or pool house facilities. All bandages must be removed before entering the pools.
5. Dressing or undressing on the grounds is restricted to the pool house.
6. Appropriate swimwear is required at all times. No cut-offs or other street clothing will be permitted. Babies must wear swim diapers or tight-fitting plastic pants at all times in the pool area.
7. No smoking at any time in the pool house or pool area.
8. Bathers must use the toilet before entering the pools.
9. Food must be eaten in the screened-in porch area (summerhouse). Please wipe off table and sweep if needed. Drinks in non-glass containers are allowed in the pool area, but no drinks in any type of container are allowed in or near the edge of the pools.
10. Anyone who has or has had diarrhea in the past two weeks shall not use the pools.
11. Children under 14 years of age and non-swimmers may not use the pools unless accompanied by a responsible adult, 18 years of age or older.
12. No glass containers in or around the pools. Use of glass is restricted to the summerhouse.
13. Pets are not allowed inside the fence or pool area.
14. Property damage caused by a Member Resident or their guest will be charged to the Member.
15. Use of facility is permitted only during the hours of 10:00 am to 9:00 pm daily and only when the “Pool Closed” sign is not posted. Sometimes it is necessary to close the pool during these hours and post the “Pool Closed” sign for safety or weather-related reasons. During these times your key fob will not allow you entry. The pool will reopen when the Pool Manager feels it safe and the “Pool Closed” sign has been removed.
16. No skateboards or roller blades are permitted in the pool house or pool area.
17. No small objects (such as coins) are to be thrown into the pools.
18. NO WATER GUNS ARE PERMITTED in or around the pools.
19. Profanity is strictly prohibited and will not be tolerated.

20. During crowded periods, there may not be enough chairs for everyone. Therefore, chairs cannot be reserved nor used for storage of personal items. We ask the cooperation of children to give up their chairs to adults.
21. Listen to music by using headphones only.
22. Balls and flotation devices will be allowed during non-crowded periods, at the discretion of the Pool Staff. If used, they must be clean and in good repair.
23. No suntan oils – only suntan lotion may be used.
24. No diving or doing flips into the pools.
25. No jumping from edge of the pools when pool is crowded, in the opinion of the Pool Staff.
26. No one over age 6 (unless directly caring for someone 6 or under) is to be in wading pool or splash fountain.
27. Sitting on step areas should not restrict others the use of the pools.
28. Member Residents of Hawthorne Park may accompany up to 4 guests per visit. Twenty-four (24) single use guest passes are allowed for the season at no cost. The Pool Staff will track the status of your “Guest Usage.” Guest usage beyond 4 guests per visit and/or Twenty-four guest for the season will cost \$3.00 per person. Payment (when required) is due when entering the pool facility. Payment may be made by either check or by cash for the exact amount, no change will be made. A Member Resident must accompany all guests.
29. No inappropriate behavior will be tolerated. This includes public intoxication or inappropriate physical contact. Please respect other Member Residents and guests. Remember this is a family pool, you must accompany all guests at all times. Babysitters or caretakers accompanying children of Member Residents are not considered guests.

**PLEASE BE AWARE:**

1. Hawthorne Park Community Association, Inc. and Pool Management Personnel are not responsible for lost, damaged, or stolen articles.
2. The Pool Manager has exclusive control over the Pool House and Pool Area at all times.
3. The Pool Manager reserves the right to change the Hawthorne Pool Rules without prior notice.
4. Pool Management has final decisions on all matters!
